### SACRAMENTO LEGISLATIVE LOBBYIST

With all the legislative activity in Sacramento, a dedicated lobbyist provides a valuable resource unavailable to most vend and coffee service operators. Our lobbyist will help CAVC work to protect the industry in California to insure favorable results relating to taxes, legislation and social issues. Our lobbyist will assist us in legislative grass roots visits, reinforce a number of stands/positions taken in Sacramento, and help pass and/or prevent legislation. During the last legislative session we worked to prevent the passage of SB 1000 which would have required a health warning label on sugar sweetened beverages and SB 1040 which required mandatory labeling of products with genetically modified ingredients. We supported SB 912 which keeps in place the healthy vending guidelines on state property that CAVC negotiated for and supported over the years.

This year we will be working together to create legislative support for a bill that will assure fairness by eliminating the 1/3 tax on snacks and some food and beverage products sold through vending. As you are aware <u>Vending is the only retail sale in California on</u> which tax is charged on all snacks, food and beverage sales.

#### ACTIVE CAVC MEMBERSHIP
