- **SACRAMENTO LEGISLATIVE LOBBYIST**

With all the legislative activity in Sacramento, a dedicated lobbyist provides a valuable resource unavailable to most convenience services operators. Our lobbyist will help CAVC work to protect the industry in California to insure favorable results relating to taxes, employment and business issues. Our lobbyist will assist us in legislative grass roots visits, reinforce a number of stands/positions taken in Sacramento, and help pass and/or prevent legislation. **During the last legislative session we worked to prevent the passage of AB 274 which would have imposed a tax on snack foods including candy and confectionery, AB 5 which would require employers to offer additional hours of work to existing employees before hiring an additional employee or subcontractor, AB 319 which would have required tethered bottle caps on beverage containers and SB 300 which would have required health warning labels on sugar sweetened beverages.**

CAVC also meet with the California Air Resources Board to discuss regulations related to the refrigerants used in vending machines. CARB has proposed going forward on regulations if the program at the federal level does not go into effect. CAVC will continue to advocate for sufficient time for the industry to comply with any new regulations.
